
Having been asked to run for office several times in my life I have always politely declined. In fact I have worked on numerous campaigns at every level and have family and friends who have held state and federal office.

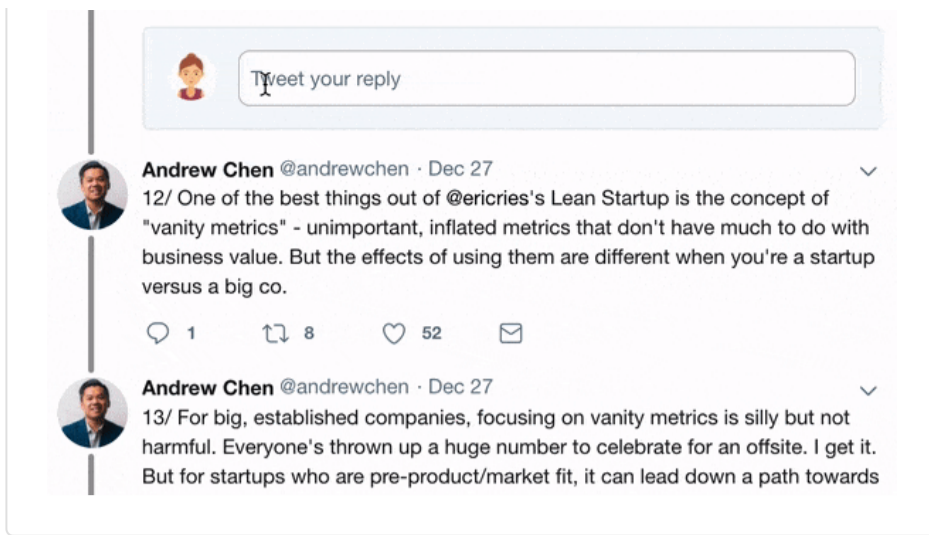

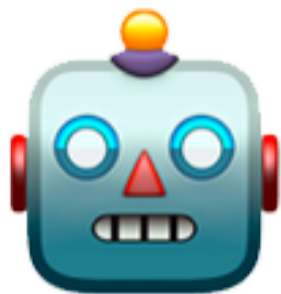
