I had to take a bathroom break so I could calm down and not "blow my cover".

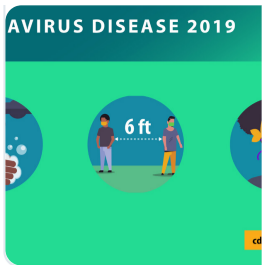
The VACC Card is supposed to be the new and only authorized government identification. Your driver's license, passport, permits, will be invalid without the additional Vacc card.

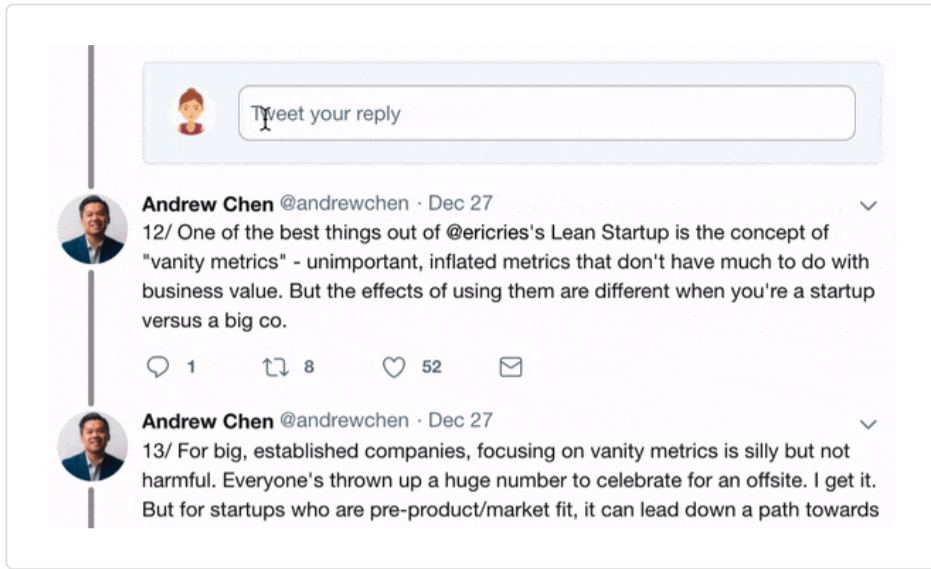

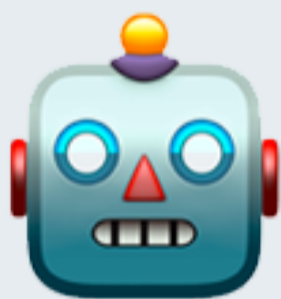
